AUTHORIZATION TO PROCESS LETTER OF AGREEMENT:

Any payments owing from Member to ChampionsGate Golf Club that are not received when due shall bear interest at the highest rate permitted by law. If Member fails to pay any amount to ChampionsGate Golf Club when due, Member shall pay all costs and expenses, of collection including reasonable attorney's fees and expenses, incurred by ChampionsGate Golf Club.

MISCELLANEOUS:

This agreement shall be governed by the internal laws of the State of Florida, This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, successors and permitted assigns. This Agreement and the rights and obligations hereunder shall not be assignable or transferable by Member without the prior written consent of ChampionsGate Golf Club. Consent may be withheld in ChampionsGate Golf Club's absolute discretion. If any term or provision of the Agreement is declared to be illegal, invalid or unenforceably, shall not affect the validity of the remainder of this Agreement, and to the extent permitted by applicable laws, any such term or provision shall be restricted in applicability or reformed to the minimum extent for such to be enforceable.
